#### **Acquisition of hydroelectric power plants**

Advising SL Capital Partners LLP / Standard Life Investments through its Norwegian subsidiaries Nordic Power AS and Nordic Hydro Holding AS in connection with the acquisition of two companies owning small-scale hydropower plants and subsequent mergers of companies in the Nordic Power group. The acquisition of Hesjeberg AS was signed in July 2017 and Mygland Kraft AS in August 2017. Wiersholm advised on due diligence, corporate, regulatory and contractual matters.
