Fosen Vind project

Assistance to TrønderEnergi AS (and the NTE group) in connection with the development of Fosen Vind DA, a joint venture between Statkraft, TrønderEnergi and Nordic Wind Power DA, for the construction of Europe's largest onshore wind power project. The project comprises six onshore wind farms in Central Norway, with a combined capacity of 1,000 MW. The work for TrønderEnergi has previously included a downward sale of the company's ownership share to the syndicate Nordic Wind Power DA established by Credit Suisse Energy and supported by the Swiss power company BKW. Wiersholm has previously acted for the senior lenders of the syndicate. The matter is important because of the size and complexity of the project and because it confirms Wiersholm's ability to assist in the most important energy projects in Norway.
